ARCHAEOLOGY, MUSEUMS AND HERITAGE DEPARTMENT ANNUAL REPORT 2020-21

1. Preamble:

The Directorate of Archaeology and Museums which was established in the year 1885 has been merged with Department of Archaeology, Museums and Heritage vide Government order No. KASAMVAPRA 10 KMU 2012 dated 23-2-2012. The Commissioner has been appointed as the head of the Department after re-structuring of the Department.

In Government Order No.KASAMVA/234/KMU/2014 dated 13-03-2015 the word *Prachayvastu* in Kannada is termed as *Puratathva* and thus the name of the Department is called as Department of Archaeology, Museums and Heritage.

The Department is rendering service in the field of **Art & Culture**, All its activities have been taken up under **plan head**.

2. Fundamental functions of the Department.

The fundamental functions of the Department include Archaeological Explorations, Excavations, Conservation of Ancient Monuments, Study of early Coins, Publication of academic and research books, Development and maintenance of Museums and organizing Cultural and Educational activities etc. All these activities have been organized in a systematic manner and also implemented by the Department.

The Department has been preserving invaluable ancient sculptures, stone edicts, coins, copper plates, etc., in the departmental Museums for the sake of posterity.

The Department has been carrying out the conservation and developmental works relating to the heritage buildings in six heritage areas because of their background historical namely: Mysore, Srirangapatna, Bidar, 2004. **Besides** 14 Gulbarga, Bijapur and Kittur during more heritage areas i.e. Sannathi, Nagavi, Kamatagi, Badami, Aihole, Bangalore, Talakadu. Lakkundi. Banavasi. Balligavi, Belur. Halebeedu, Malkheda, Melukote, have been declared as Heritage areas on par with the budget

speech for the year 2012-13. The documentation and integrated management plan of all the 20 heritage cites consisting of ancient monuments and buildings has been completed with inventorying prior to carrying out conservation of all these relics.

The department has in its administrative jurisdiction 5 offices of Deputy Director at Mysore (Heritage), Gulbarga, Bengaluru, Dharwad and Kamalapur (Hampi). There are about 16 Government Museums in places like Bangalore, Chitradurga, Shimoga, Mysore, Srirangapatna, Hassan, Madikeri, Mangalore, Kittur, Gadag, Gulbarga, Raichur, Basavakalyana, Hoovinahadagali and Sculpture Gallery at Athani. There is an Venkatappa Art Gallery at Bangalore.

15. Conservation of Monuments under Public Partnership Scheme.

Government order no: Sam Ka E 97 KMU 2001 Dated:19.11.2001, Monuments Conservation work is being carried out by Sri Dharmasthala Manjunatheshwara Dharmothana Trust with the collaboration of Archaeology, Museums and Heritage, Mysuru under the Public Partnership Scheme from 2002-03. Under this Scheme, the estimated 40:40:20 ratio (Government:Private:Public) is being carried out.

Under this Scheme, Government has approved the implementation of 16 Conservation works for the year 2019-20 with a Grant of Rs. 80.00 Lakhs.

Under the above plan, a total of 186 various temple / monuments have been rehabilitated so far at a cost of Rs.22.01 Crore, of these, 170 works have been completed, while the remaining 16 are in progress. For these works Rs. 880.52 lakhs have been released by the government at a ratio of 40%. The remaining Rs. 13.30 crore will be borne by Shri Dharmasthala Trust and Temple Committee.

16. Appointment of personnel from outsourcing by the outside Agency:

The security personnel have been appointed through the outsourcing agencies to look after State Protected Monuments and Museums coming under the jurisdiction of the department after following the procedure under KTTP Act and Rules by calling tenders. As per Government Order a grant of Rs.42.58 lakhs has been released to Hampi World Heritage Management Authority for their annual maintenance during 2020-21 under grant-in-aid and general expenditure.

b) Chalukya Development Authority:

As per Government Order a grant Rs.1.00 lakhs has been released for the development for Authority during the financial year 2020-21.

c) Lakkundi Development Authority:

As per the budget speech of 2017-18 Lakkundi Development Authority is constituted as per the Government order TOR 91 TDA 2020 22.12.2020 Lakkundi Development Authority is constituted by the Government of Karnataka and Implemented from 21.12.2020.

The Department has in its possession a very rare library consisting of books mainly on archaeology, history, art, culture, Heritage etc., with a collection of approximate 18398 books which will cater to the needs of scholars, researchers and public, free for entrance. Interested persons and academicians are utilising the services of this library.

• A total of 57 monuments conservation works have been implemented under the Department of Tourism in the year 2020-21, of which 5 works have been completed and 51 works are in progress.

26. Conservation Planning.

In the Budget Speech 253 of 2020-21, a conservation plan has been announced for the phased conservation and revitalization of temples, ancient sites / monuments in the state. For this purpose, the Government has given its approval on 05.01.2021. This is not a grant announcement in the budget.

Rs 10.00 lakhs has been allocated in the current financial year in the State Plan Survey work is being progressed through the Grama Niladhari Survey in 5 taluks of Chikkaballapur, Shikaripura, Kalburgi, Hassan and Kittur through departmental staff.

27. Karnataka's addition four sites to the UNESCO World Heritage Sites:

- Three sites selected from Karnataka to the World Heritage Tentative List have been submitted by Dossier for inclusion in the final list. The work of a site is in progress.
- Monuments and forts of Deccan Sultanate Dossier and Site Management Plan for Inclusion of World Heritage Final List, prepared by The Indian Heritge Cities Network Foundation, Bangalore.
- Sacred Ensembles of the Hoysala (Hoysala Architecture series including Belur, Halebidu): The Dossier and Site Management Plan for the inclusion of the World Heritage Final List has been prepared by the INTAC for Rs. 82.00 lakhs.
- TEMPLE ARCHITECTURE (AIHOLE-BADAMI- PATTADAKAL): A collection of monuments in the Aihole, Badami and Pattadakal area to be added to the World Heritage Final List by the Indian Heritge Cities Network Foundation, Bangalore The list was submitted in January 2021 for review by the selection committee
- Monuments of Srirangapatna Island Town (Srirangapatna): The Dossier and Site Management Plan is being prepared by INTAC for Rs.64.00 Lakh.

28. Implementation of Financial Declaration Programs 3D Mapping and Laser Scanning Digital Recording.

• The conservation of these monuments will be carried out in the Budget Speech 309 for the year 2019-20, with a survey of the Department's total of 844 protected monuments, including 600 monuments in another five years.



- Karnataka State Science and Technology Board, Bangalore, with the signing of the agreement by the Karnataka State Science and Technology Board, Bangalore, with a cost of Rs.64.91 laks The program has been given a run.
- 3D Mapping and Laser Scanning of 105 Monuments of Bangalore Division has been completed by 2019-20.
- 3D mapping and laser scanning of 125 monuments of Mysore Division in 2020-21 is in progress.
